01. Market Commentary

DSEX ended in green for the week increasing by 165.56 points [3.16%] compared to the previous week. It stands at 5399.94 points.

Index continued its upward trajectory for the fourth consecutive week as investors remained bullish on certain blue-chip stocks and overall equities as they anticipate stabilization of the market after the national elections are held. Although the initial market session was met with profit taking, the last two sessions exhibited bullish market sentiment wherein the index rose by above 150+ points.

Investor participation decreased by 5% as compared to the previous week and remained around the BDT 600 Crore mark. Investors' trades in this week focused on Bank scrips followed by Pharmaceuticals and Textile scrips. In terms of sectoral returns, all sectors were positive, with the Financial Institutions sector posting the highest increase of 6.23%

Market capitalization stands at USD 58.0 Billion*.

02. Related Regulatory Decisions



1. As per decision of the monetary policy committee, Bangladesh Bank has revised down the Standing Deposit Facility (SDF) rate from 8% to 7.50% for greater enhancement of fund liquidity and call money market operations. The Standing Lending Facility (SLF) rate will remain at 11.5% and the policy rate will be kept unchanged at 10% until the desired level of inflation has been reached.


